



## MÉRIDA EXTREMA GUITARS U.S. LIMITED LIFETIME WARRANTY

**Mérída Extrema Guitars U.S.** warrants your *Mérída Extrema Guitar* to be free from defects in materials and craftsmanship under normal use and proper care from date of purchase to the original purchaser when purchased from an authorized **Mérída Extrema Guitars U.S.** dealer, for as long as the instrument is owned by the original purchaser. This is a limited lifetime warranty, which is not transferable. **Mérída Extrema Guitars U.S.**, at its sole discretion, will repair or replace any of its guitars and / or parts that it finds to be defective.

If you are the original purchaser of your *Mérída Extrema Guitar*, and it requires service of any kind, please first contact the authorized **Mérída Extrema Guitars U.S.** dealer from which the instrument was purchased. If service is warranted, you will be directed to the independent **Mérída Extrema Guitars U.S.** warranty service center closest to you. This limited lifetime warranty covers both the cost of labor and materials on any repair deemed necessary by **Mérída Extrema Guitars U.S.**

The following components are covered for a period of *one (1) year* from the date of original purchase:

- Pickguards
- Tuning machines
- Hardware
- Plated surfaces
- Cases (including case hardware)
- Any Fishman® electronic components

This Limited Lifetime Warranty does *not* cover:

- Wear or breakage of frets or strings, and other normal wear and tear of the instrument or its parts
- Defects or damages caused by any modifications, misuse, abuse, neglect, or improper care of the instrument
- Damage and deterioration caused by accidents
- Any and all charges if no fault in manufacturing or materials is found
- Any cracking, discoloration, or damage to the finish or plating
- Instruments that have been exposed to extreme or extreme lack of humidity or temperature conditions
- Routine maintenance of the instrument
- Instruments whose serial number, identification number, or trademark have been modified or removed
- Instruments purchased from an unauthorized **Mérída Extrema Guitars U.S.** dealer
- Instruments that have been serviced by unauthorized persons (*i.e.*, any person other than an authorized **Mérída Extrema Guitars U.S.** service technician)

All transportation, insurance, and freight charges are the responsibility of the original purchaser. Warranty service requires the proof of purchase to be presented at the time of service request. **Mérída Extrema Guitars U.S.** assumes no liability for property damage or personal injury to self or others resulting from failure of this product, nor any loss of income, wages or profit arising from the loss of use of instrument due to defects. **Mérída Extrema Guitars U.S.** is not responsible for any items left in gig bags or cases. We strongly recommend that all personal items, picks, cables, etc. be removed.
